
A. on operating the room






- F. (Discussion of) open policy proposals (1)
- 2015-04
 - "RIPE Resource Transfer Policies"
 - v4.0 in review phase since September 27
 - * quite a bit of discussion on the list
 - * main opposing argument left (so far): introduction of "24 month holding period" for resources acquired via mergers & acquisitions.
 - short presentation by Erik Bais
 - then Q&A





- 2016-03
 - "Locking Down the Final /8 Policy"
 - heated and controverse discussion in "discussion phase"
 - at the end of the discussion phase, the PDP does not(!)
 require community consensus to go ahead, only agreement
 by proposer and WG chair
 - summary and reasoning posted to APWG list
 - in review phase since October 19
 - would need much stronger support in this phase to go ahead
 - short presentation by Remco van Mook, then Q&A








